PHOTO PLAQUES

Photo Plaques are permitted to be displayed on graves subject to the following conditions:

- (1) The size of the plaque, either oval or square shaped, is not to exceed 9cms x 7cms and the photo image encased in a sealed unit produced by an approved manufacturing process.
- (2) The plaque may only be affixed to the Headstone.
- (3) Only the photograph of the person (or persons) actually interred in the grave may be displayed. (Thus where an Exclusive Right of Burial has been granted it is possible that the headstone may display as many as 3 photo plaques for family members interred in the same grave space.)
- (4) The Committee will not accept responsibility for fading of the photo image, loss of colour, vandalism or damage howsoever caused except where it can be satisfactorily shown the damage was done by cemetery staff acting in the course of their duties.
- (5) An additional fee will be charged to the applicant to mount and display the plaque(s) which must be properly and securely affixed by a recognised monumental mason.

MEMORIAL TREE

Memorial Trees are available in Devizes Cemetery on the following terms and conditions:

- (1) If the applicant wishes to erect a plaque this must be of a standard size 7" x 6" and will be supplied, lettered and fixed by the Joint Burial Committee.
- (2) The maximum number of letters permitted on the plaque is 54.
- (3) Details of the lettering must be submitted and approved by the Joint Burial Committee.
- (4) The cost of the lettered and affixed plaque will be that shown on the current schedule of fees.

MEMORIAL BENCHES

Memorial benches are permitted in Devizes Cemetery; details of those suitable will be supplied upon application. Only approved styles will be permitted, these will be supplied at cost and sited by Cemetery staff at an agreed location.
