**7. REPORT FOR DECISION – PROPOSED TRAFFIC REGULATION ORDERS - VICTORIA ROAD**

**Recommendation**

That the committee reviews the proposed amendment to operational hours for residential parking in Victoria Road.

**Purpose of the Report**

To respond to the Wiltshire Council consultation on an amendment to operational hours for residential parking in Victoria Road.

**Background**

Wiltshire Council has published its proposed traffic regulation orders for an amendment to the operational hours for residential parking in Victoria Road. The effect of the proposed order will be to amend the operational days and hours of the residential parking from Monday to Friday 8am to 6pm Zone a permit holders only to *Monday to Saturday 8am to 8pm Zone a permit holders only*.

**8. REPORT FOR DECISION – CHANGES IN PARKING ORDERS FOR OFF STREET PARKING IN DEVIZES**

**Recommendation**

That the committee notes traffic order consultation and decides what comment, if any, it wishes to make in response.

**Purpose of the Report**

To review the amendment to off street parking places traffic orders for Devizes as set out in the formal consultation.

**Background**

It has been brought to the attention of officers that Wiltshire Council have commenced the formal consultation period ahead of the implementation of amended traffic order for off street parking in Devizes. The order, doc 8/1 sets out the following changes.

- The ability to charge in the Market Place between 8am and 6pm
- Charging for Sundays in all car parks
- Changes to season ticket prices
- Night time charging, although this is not clear as the order only deals with Sundays and Bank Holidays.

It is normal for the Council to be consulted on traffic order directly but at the time of this agenda preparation no formal notification has been received and given the deadline for responses officers felt it would not be prudent to wait for it to be received.
