At its meeting on the 6 January, the committee confirmed that it was not prepared to compromise on their original objections to an increase in the licencing times for the above property and confirmed that a representative would attend the licensing hearing.

The hearing was conducted on the 19 January and Councillor Peter Evens appeared on behalf of the Town Council to substantiate the objection.

Following the opportunity each party had to state their case, the Licencing Committee resolved to agree the licence amendment, as requested.

Whilst the Licensing Committee did listen to the views of the Town Council, there was no evidence to support the position it had forward; however the legal representative for Central Stores was able to show that there were a number of other Central Store, one of which is in Potterne, that have these licencing hours and are also in residential areas.
