7. REPORT FOR INFORMATION – TEMPORARY ROAD CLOSURE – A342 St EDITHS MARCH (PART), BROMHAM (REF TTRO 3491)

Notice is hereby given that the Wiltshire Council has made an Order to close temporarily to all traffic:

A342 St Ediths Marsh (Part), Bromham; from its junction with Hawkstreet to its junction with Netherstreet.

To enable: Wiltshire Council to carry out carriageway resurfacing and associated works.

Alternative Route: Via A342 (unaffected length) – A3102 – A4 – C50 – A361 – A342 (unaffected length).

The closure will be clearly indicated by traffic signs throughout.

The Order will come into force on 21st July 2014 and it is anticipated the works will take 1 day between the hours of 9am and 3pm to complete. The Order will have a maximum duration of 18 months.

8. REPORT FOR INFORMATION – HIGHWAY INSPECTIONS

Wiltshire Council has issued all Parish Councils with a copy of their Highway Inspection Manual dated 2013.

The manual (issued alongside this agenda) sets out Wiltshire Council's policy and procedures relating to Highway safety inspection and give descriptions of the road hierarchy and the frequency of inspections. The manual goes on to identify type of defects and the priority and time scales for their rectification.
